AN ORDINANCE OF THE VILLAGE OF EAGLE, CASS COUNTY, NEBRASKA, TO AMEND CHAPTER 4, ARTICLE 4-5, SECTION 4-501, OF THE VILLAGE OF EAGLE, NEBRASKA PERSONNEL POLICY MANUAL AS THE SAME RELATES TO HOLIDAYS; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR THE SEVERABILITY OF ANY SECTION, CLAUSE, PROVISION OR PORTION FOUND UNCONSTITUTIONAL OR INVALID; TO PROVIDE THAT THIS ORDINANCE SHALL BE PUBLISHED AND SHALL BE IN FULL FORCE AND TAKE EFFECT FROM AND AFTER ITS PASSAGE AND APPROVAL, AS PROVIDED BY LAW AND AS PROVIDED HEREIN; AND TO PROVIDE THAT THE PROVISIONS OF THIS ORDINANCE SHALL NOT BECOME AND BE MADE A PART OF THE MUNICIPAL CODE OF THE VILLAGE OF EAGLE.

VILLAGE OF EAGLE

December 19, 2022

The Village Board of Trustees met in regular session at 7:00 p.m. on December 19, 2022 with Todd, Hochstein, Meier and Dobbins present. Caylor was absent. The Agenda items listed thereon were sufficiently descriptive to give the public reasonable notice of the matters to be considered at the meeting. The Chairperson, at the beginning of the meeting, informed the public about the location of the posted current copy of the Open Meetings Act. Chairperson Surman named the three (3) areas where the agenda was posted as follows: Eagle Municipal Building, Eagle Fire & Rescue Department and Eagle Municipal Park. The Pledge of Allegiance was recited.

Report from Fire & Rescue – Makinsey Lonergan (Rescue Captain) reported 6 rescue calls, 5 fire calls and 4 car accidents since the November 21, 2022 board meeting. The department's annual soup supper will be held in February. Lonergan said the CPR Instructor Course was attended by six members of the department; CPR certification will be offered to employees, board members and the public in the near future.

Motion by Hochstein, second by Dobbins, to approve the following slate of appointments: Planning Commission – Justin Davidson & John Surman (Alternate); Board of Adjustment – Terry Caddy & Mike Nespor; Board of Appeals – Ken Musil; and Park & Recreation Commission – Elizabeth Umshler, Cassidi Denton, Tracy Masek & Amber Doser. Voting: Ayes – 4. Motion carried.

Open Forum – No public comment.

Discuss/possible action: Approve the 2023 Annual Investment with Cass County Nebraska Economic Development Council in the amount of \$2,000 - Julie Schmale (President) of Cass County Nebraska Economic Development Council (CCNEDC) provided the Village Clerk with an update on the year-to-date numbers across Cass County which was shared with the Village Board ahead of tonight's meeting. Nystrom said CCNEDC is still in the process of hiring a new Executive Director to replace Jennifer Serkiz. Todd asked for a summary of what CCNEDC provides to communities in Cass County. Nystrom said CCNEDC's primary purpose is to promote economic development by attracting, retaining and expanding businesses in Cass County. Hochstein asked if CCNEDC has ever been responsible for landing new business opportunities in Eagle; from his research, it appeared as if most of the efforts go towards assisting Plattsmouth. Nystrom said Plattsmouth does tend to receive more support as they offer more of an investment to the program and have broader available options for commercial expansion and growth. In the past, the Village Board has tasked CCNEDC with developing a partnership with Lincoln's economic development council due to our proximity with the city and our location on the western edge of Cass County. Nystrom said he is aware that Serkiz has at least initiated these conversations with Lincoln but does not know specifically where she left off since resigning from her position. Terry Caddy said he served on the board of CCNEDC for twelve years and at that time was a strong proponent of Eagle being a contributing member; the issues he has presently include the local CCNEDC representative not attending meetings regularly and what happened to the money Eagle contributed last year when CCNEDC has been without an Executive Director for several months. Nystrom added that CCNEDC is looking to expand their board and include an at-large representative from Eagle if anyone is interested in volunteering. The Village Board generally agreed to table the agenda item until January and invite a representative from CCNEDC to attend a future meeting for further discussion and consideration. No action taken.

Motion by Hochstein, second by Meier, to approve Crazy Cracker's Fireworks Permit Application for December 29-31, 2022 at 510 Highway 34. Voting: Ayes – 4. Motion carried.

Discuss/possible action: Approve estimate from Custom LED Lighting for dedicated security camera system screens in the amount of \$400.00 each — Meier said he would like to see the Village Office have a couple of dedicated monitors which would allow the staff to view the security cameras at all times. Hochstein expressed his concerns with the past quality of products provided by the vendor and whether or not some of the products found in the proposal, such as the video cards, are absolutely necessary. Meier said he would want to ensure the monitors are of proper quality as well. Dobbins said as a member of the Technology Committee he would like more time to research the proposal and consider shopping around for another option(s). Meier said it is possible the items can be purchased and installed internally by staff and/or board members. Hochstein said his son has a computer and technology background and said he feels he could meet or exceed what is being proposed tonight. Agenda item tabled until a future board meeting. No action taken.

ORDINANCE NO. 2022-08

AN ORDINANCE OF THE VILLAGE OF EAGLE, CASS COUNTY, NEBRASKA, TO AMEND CHAPTER 4, ARTICLE 4-5, SECTION 4-501, OF THE VILLAGE OF EAGLE, NEBRASKA PERSONNEL POLICY MANUAL AS THE SAME RELATES TO HOLIDAYS; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR THE SEVERABILITY OF ANY SECTION, CLAUSE, PROVISION OR PORTION FOUND UNCONSTITUTIONAL OR INVALID; TO PROVIDE THAT THIS ORDINANCE SHALL BE PUBLISHED AND SHALL BE IN FULL FORCE AND TAKE EFFECT FROM AND AFTER ITS PASSAGE AND APPROVAL, AS PROVIDED BY LAW AND AS PROVIDED HEREIN; AND TO PROVIDE THAT THE PROVISIONS OF THIS ORDINANCE SHALL NOT BECOME AND BE MADE A PART OF THE MUNICIPAL CODE OF THE VILLAGE OF EAGLE.

WHEREAS, the Village of Eagle offers paid holiday benefits to all regular full-time and part-time employees averaging at least twenty-four (24) hours per week.

NOW, THEREFORE, BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF EAGLE, NEBRASKA, as follows:

Section 1. Chapter 4, Article 4-5, Section 4-501 of the Village of Eagle, Nebraska Personnel Policy is amended as indicated:

Article 4-5: Holidays

SECTION 4-501: All regular full-time employees will receive the following holidays off with pay:

New Year's Day	Martin Luther King, Jr. Day
Presidents' Day	Memorial Day
Juneteenth	Independence Day
Labor Day	Columbus Day/Indigenous People's Day
Veterans Day	Thanksgiving Day
Day after Thanksgiving	1/2 day on Christmas Eve
Christmas Day	•

SECTION 4-502: Regular part-time employees averaging at least 24 hours per week will receive pro-rated holiday pay based on average hours worked per week, provided the employee would have otherwise been scheduled to work on the holiday. Regular part-time employees averaging less than 24 hours per week and temporary/seasonal employees are not eligible for paid holidays.

SECTION 4-503: If any holiday falls on a Saturday, it will be observed on the preceding Friday. If any holiday falls on a Sunday, it will be observed on the following Monday. If a holiday occurs during an employee's approved leave time, the employee will receive holiday pay and the day will not be charged against the employee's leave.

Section 2. That the Chair and the appropriate Department, whether one or more, of the Village of Eagle, Nebraska, are hereby authorized and directed to implement this Ordinance.

Section 3. That all Ordinances and parts of Ordinances passed and approved prior to the passage, approval, and publication of this Ordinance, in conflict herewith, are hereby repealed.

Section 4. That should any section, paragraph, or sentence of this Ordinance hereby adopted be declared for any reason invalid, it is the intent of the Chair and Governing Body of the Village of Eagle, Nebraska, that it would have passed all other portions of this Ordinance independent of the elimination here from of any such portion as may be declared invalid.

Section 5. That this Ordinance shall be published within the first 15 days after its passage and approval either in pamphlet form or by posting in three public places in the Village of Eagle, Nebraska, and shall be in full force and take effect on the 15th day from and after its passage, approval, and publication, as provided herein.

Section 6. That it is the intention of the Chair and Governing Body of the Village of Eagle, Nebraska, and it is hereby ordained that the provisions of this Ordinance shall amend the Village of Eagle, Nebraska Personnel Policy Manual.

Report on Streets and Maintenance – Terry Caddy said the snow equipment was tested today during the first true snowfall of the season and everything worked properly. The area could see more significant snowfall and high winds later this week. Todd said the maintenance department did a good job with snow removal today. Hochstein asked if the contractor burying fiber for Windstream has given any indication as to when they will repair the alley adjacent to his property that was not properly compacted. Nystrom said the contractor (VPS Construction) informed him they plan to perform touch-up repairs at the conclusion of their project.

Report on Wells and Sewer – Caddy said the wells are pumping an average of 85,000 gallons of water per day compared to approximately 92,000 gallons per day entering the WWTP. Two loads of sludge were hauled out of the WWTP ahead of the winter season. Caddy said two fire hydrants were found to be leaking from their bottoms when under pressure. Meier and Hochstein recommended obtaining a bid(s) for a couple of new fire hydrants so they can be on hand if the need for replacement arises.

Motion by Hochstein, second by Dobbins, to accept the Fiscal Year 2022 Audit as presented by Gabriel, Burger & Else, CPA, P.C. Voting: Ayes – 4. Motion carried.

Motion by Dobbins, second by Meier, to approve Nick Nystrom attending the 2023 Nebraska Clerk's Conference Academy in Kearney on March 14-17, 2023 at a cost of \$223.00 plus lodging in an amount not to exceed \$550.00. Voting: Ayes – 4. Motion carried.

Motion by Meier, second by Hochstein, to approve minutes as typed for the previous meeting. Voting: Ayes – 4. Motion carried.

Report from Committees and Boards – Meier said the three new security cameras that were previously approved were installed at the park. Snow removal and snow emergency procedures were discussed. Caddy said in order to handle snow procedures appropriately he would recommend maintenance inform the Village Clerk if they need assistance from the snow removal contractor; this would help prevent miscommunication and having too many individuals moving snow at the same time.

Discuss/possible action: Updates on the available Full-time Maintenance position – Nystrom said the Human Resources Committee interviewed an individual today that is interested in the available position. This individual has a Grade III Water Operator License, a Grade L Wastewater License and 22 years of municipal experience. Meier asked if salary was discussed. Todd said yes; currently, the desired salary is above what can be offered due to Eagle's need for a Grade II Wastewater License; however, the potential exists that the individual could become the Maintenance Supervisor upon obtaining the proper credentials which would allow for more competitive salary negotiations. Nystrom said at this time the individual is taking into consideration the time frame for obtaining his Grade II Wastewater License and more information will be shared with the Village Board once it is known. No action taken.

The meeting was adjourned at 7:48 p.m.
