RESOLUTION NO. 2024-03

A RESOLUTION OF THE EAGLE BOARD OF TRUSTEES PROCLAIMING JUNE 9, 2024 AS BATTEN DISEASE AWARENESS DAY

WHEREAS, the Village of Eagle, Nebraska is observing June 9, 2024 as Batten Disease Awareness Day to educate the public globally about this ultra-rare genetic disorder; and

WHEREAS, although approximately 14,000 people around the world are living with Batten Disease and 2 to 4 in every 100,000 births is diagnosed with one of the 13 known forms of Batten Disease, it is still relatively unknown to the public; and

WHEREAS, Batten Disease is a heritable disorder, requiring both parents to carry the defective gene, there are significantly more (known and unknown) unaffected siblings who are carriers; and

WHEREAS, Batten Disease essentially affects all populations equally, regardless of race, ethnicity, or gender; and

WHEREAS, symptoms of this fatal disease typically include vision loss leading to blindness, the inability to walk, talk, or swallow, often requiring surgical insertion of a gtube for nourishment, personality and behavioral changes, frequent seizures, intellectual decline, disruption and loss of speech, dementia, and other debilitating ailments; and

WHEREAS, the disorder currently has few treatment options available and clinical trials and research endeavors have been significantly delayed or stopped altogether due to the global pandemic and current landscape of the biotech industry; and

WHEREAS, BDSRA (Batten Disease Support, Research & Advocacy) along with many Batten family foundations are leading the collective effort to promote and financially sponsor world-class medical research aimed at finding effective treatments, with the ultimate goal of finding a cure; and

WHEREAS, Batten families along with BDSRA and many Batten Family Foundations are always advocating for and connecting the unconnected, leading the way through innovative and inventive approaches to scientific advancement and improved patient care, revamping systems to accelerate the path from discovery to treatment; and

WHEREAS, much remains to be done in raising public awareness of Batten Disease to help promote early diagnosis, carrier testing, proper management and treatment, and support for research;

NOW, THEREFORE, BE IT RESOLVED, that the Chair and Board of Trustees of the
Village of Eagle, Nebraska, in recognition of this important initiative, do hereby proclaim
June 9, 2024 as Batten Disease Awareness Day.

The sum of \$4.00 shall be charged for each 1000 gallons of water used based upon the average amount of water metered for the premises, occupied by the current occupant or tenant, per month during the preceding winter quarter (January, February, and March). If there is no established usage for the previous January, February and March period for the premises occupied by the current occupant or tenant, then a flat monthly rate set by resolution by the Governing Body, annually, shall be charged, until a January, February and March water usage average can be established.

WHEREAS, the Chair and Board of Trustees of the Village of Eagle, Nebraska deem it in the best interests of the citizens of the Village of Eagle, Nebraska, that said flat monthly rate be established for the period this Resolution is passed, until the anniversary of passage,

NOW, THEREFORE, be it resolved by the Chair and Board of Trustees of the Village of Eagle, Nebraska, as follows:

- 1 That the findings here and above made should be and are hereby made a part of this Resolution as fully as if set out at length herein.
- 2 That the flat monthly rate required by the Ordinance set forth above shall be the amount of \$20.00 per month.
- 3 That the effective date of this rate shall be May 1, 2024 and shall expire on April 30, 2025.

The Agenda items listed thereon were sufficiently descriptive to give the public reasonable notice of the matters to be considered at the meeting. The Chairperson, at the beginning of the meeting, informed the public about the location of the posted current copy of the Open Meetings Act. Chairperson Todd named the three (3) areas where the agenda was posted as follows: Eagle Municipal Building, Eagle Fire & Rescue Department and Eagle Municipal Park. The Pledge of Allegiance was recited.

Report from Law Enforcement – Sergeant Boehm reported 29 citations, 15 warnings and equipment violations, and 36 calls for service during the month of March. Hochstein inquired about the auto theft on March 1, 2024. Boehm said this call was the recovery of a stolen automobile out of Lancaster County.

Report from Building & Zoning Administrator – Hestermann reported 1 new building permit, 2 certificates of occupancy and 6 inspections during the month of March. There are 11 total open permits to date. Hestermann said the two letters that were sent on January 31, 2024 regarding property maintenance code violations have not been acted upon by the property owners. Nystrom will work with the Village Attorney and identify a contractor to perform necessary repairs at the property on Eagle Drive.

Open Forum – No public comment.

Dan Manley to discuss: Waivers related to paved roads for new subdivisions in Eagle's ETJ pursuant to the Minimum Street Standards found in the Eagle Subdivision Regulations – Manley canceled his appearance before the Village Board. No discussion was held.

WHEREAS, the Municipal Code of the Village of Eagle, Nebraska, and in particular Ordinance §3-223, provides the following:

The sum of \$4.00 shall be charged for each 1000 gallons of water used based upon the average amount of water metered for the premises, occupied by the current occupant or tenant, per month during the preceding winter quarter (January, February, and March). If there is no established usage for the previous January, February and March period for the premises occupied by the current occupant or tenant, then a flat monthly rate set by resolution by the Governing Body, annually, shall be charged, until a January, February and March water usage average can be established.

WHEREAS, the Chair and Board of Trustees of the Village of Eagle, Nebraska deem it in the best interests of the citizens of the Village of Eagle, Nebraska, that said flat monthly rate be established for the period this Resolution is passed, until the anniversary of passage,

NOW, THEREFORE, be it resolved by the Chair and Board of Trustees of the Village of Eagle, Nebraska, as follows:

Report from Attorney – Freeman-Caddy said she continues to work with Cass County and the Sheriff's Department to implement citations into the system for municipal code violations. The attorney representing the Eagle's Landing subdivision has recently been discussing his client's interest in developing to the south on the Carr property; his interest included possible tax increment financing (TIF) and/or the creation of an SID. The Village office has received a few citizen complaints regarding members of Eagle Fire & Rescue washing private vehicles with a municipally owned pressure washer. Freeman-Caddy there is State regulations on using municipal property for personal benefit and she has sent guidelines on these types of instances in the past.

Report from Clerk/Treasurer – Nystrom said the 6th Street (D-F St.), D Street (5th-6th St.) and 2nd Street (D-F St.) Asphalt Mill & Overlay Project will be advertised for bids in the April 4th and April 11th editions of The Voice News; bids will be due on April 25th with a substantial completion date of June 7th and final completion date of June 28th. The Village office is wrapping up conversations with the Village Engineer ahead of construction plans and bidding for the 6th Street Water Main Extension project. The Eagle Facilities & Grounds Association (EFGA) will hold its annual meeting in April.

Nystrom said the FCC licenses at Eagle Fire & Rescue have been updated. The annual Form 35K was completed for Keno. Nystrom said there are currently 7 applications for the pool this year and the hope is to obtain 3-4 more employees before the season begins. The Village office continues to work on the federally mandated Water Service Line Inventory that is due to NDEE by October 16, 2024. The Planning Commission will have its first meeting of the year on April 23, 2024 and will have two conditional use permit public hearings regarding shipping containers for exterior storage. Nystrom said the total monthly income ending March 31, 2024 was \$89,660.75.

The meeting was adjourned at 7:39 p.m.
