The Village Board of Trustees met in regular session at 7:00 p.m. on July 5, 2023 with Todd, Hochstein, Meier and Dobbins present. Caylor was absent. The Agenda items listed thereon were sufficiently descriptive to give the public reasonable notice of the matters to be considered at the meeting. The Chairperson, at the beginning of the meeting, informed the public about the location of the posted current copy of the Open Meetings Act. Chairperson Todd named the three (3) areas where the agenda was posted as follows: Eagle Municipal Building, Eagle Fire & Rescue Department and Eagle Municipal Park. The Pledge of Allegiance was recited.

Open Forum – Terry Thoene said his five-year old son was diagnosed with Batten Disease at the age of three. Thoene read the proclamation by Batten Disease Support, Research & Advocacy (BDSRA) declaring June 9th as Batten Awareness Day. The Village Board agreed to consider adopting a resolution to recognize June 9th as Batten Disease Awareness Day at a future meeting next spring. Thoene discussed his desire to leave the Eagle Estates park space as a green area and consider extending a public sidewalk to the adjacent MoPac Trail. Terri Todd thanked Nick Nystrom, Terry Caddy and Curtis Klabenes for working late last night after the storm to keep the generators running at the facilities. James Dobbins asked when Black Hills Energy plans to have natural gas running to the west lift station generator. Nystrom said the goal is by next week.

VILLAGE OF EAGLE

July 5, 2023

The Village Board of Trustees met in regular session at 7:00 p.m. on July 5, 2023 with Todd, Hochstein, Meier and Dobbins present. Caylor was absent. The Agenda items listed thereon were sufficiently descriptive to give the public reasonable notice of the matters to be considered at the meeting. The Chairperson, at the beginning of the meeting, informed the public about the location of the posted current copy of the Open Meetings Act. Chairperson Todd named the three (3) areas where the agenda was posted as follows: Eagle Municipal Building, Eagle Fire & Rescue Department and Eagle Municipal Park. The Pledge of Allegiance was recited.

Report from Law Enforcement – Sheriff Sorenson reported 12 citations, 30 warnings and equipment violations, and 46 calls for service during the month of June. The Village Board discussed its two primary enforcement concerns; the operation of unlicensed off-road vehicles on Municipal streets and vehicles parking along the street beyond the established time limits. Freeman-Caddy said she has not heard of any citations being issued for the illegal operation of off-road vehicles since the law went into effect in January, 2022. Sorenson said he has been working diligently on changing the culture and processes of the department after being elected Sheriff last year but it will take some time. Hochstein said every month the Sheriff's Office representative who attends the board meeting is reminded of these same issues and it doesn't appear anything is being done to address them. Sorenson said he will continue to urge accountability and ownership to his officers. Meier asked what the best process is to issue parking warnings for those in violation of the parking time limits. Sorenson said the best method is to send an email to the chain of Sheriff's Office leadership to ensure the situation is handled promptly.

Report from Building & Zoning Administrator – Hestermann reported 2 new building permits, 4 certificates of occupancy and 6 inspections during the month of June. There are 18 total open permits to date. Meier asked if there are any regulations requiring trampolines to be tied down. Hestermann said no. The Planning Commission conducted a zoning regulation workshop on June 26, 2023.

Utilizing the existing concrete pad on the west side of the park is the preferred option. The cost of asphalt surfacing, net, fencing and paint will need to be determined and considered in next year's budget. No action taken.

Discuss/possible action: Updates on Frisbee Golf proposal at Eagle Municipal Park – Todd said the Eagle Parks & Recreation Commission discussed Frisbee Golf at their June 26, 2023 meeting and a preferred layout was determined. The cost of basket numbers, paint, concrete and signage still needs to be determined. No action taken.

Report from Attorney – Freeman-Caddy said a second Planning Commission zoning regulation workshop will be scheduled prior to a public hearing being set to adopt the new zoning ordinance document. The property at 509 South 4th Street was discussed and whether or not it contains any property maintenance code violations. Unlicensed vehicles and vehicles parking on non-hard surfaced areas were discussed.

Report from Clerk/Treasurer – Nystrom said an invitation for bids will be published on July 13, 2023 for the upcoming CIPP sewer lining project. Nystrom provided the Village Board with a monthly disposal fee comparison study for recycling services. The total recycling costs during Fiscal Year 2023 have totaled \$14,688.01 (\$15,000 was allocated in the budget). Nystrom discussed swimming pool admission revenue; this year, the total revenue for May and June is \$19,097.00; this is an increase of \$3,852.50 from last year at this time. The illegal parking of a trailer along Eagle Drive was discussed. Nystrom said the total monthly income ending June 30, 2023 was \$138,593.57.

Motion by Hochstein, second by Dobbins, to go into executive session at 8:13 p.m. for the purpose of discussing possible real estate negotiations. Voting: Ayes -4. Motion carried.

Chairperson Todd said the board has come out of executive session at 8:51 p.m. after discussing possible real estate negotiations. No action taken.
