FIRST AMENDMENT TO SUBDIVISION AGREEMENT

This First Amendment to Subdivision Agreement ("Amendment") is made this
, 2024 ("Effective Date") by and among MDC Eagle One, LLC, a Nebraska
liability company ("Owner"), Sanitary and Improvement District No. 12 of Cass County,
cal subdivision of the State of Nebraska ("District") and the Village of Eagle, Cass
Nebraska, a municipal corporation ("Village") and, collectively with the Owner and the
 the "Parties".

RECITALS:

WHEREAS, Owner, District and Village entered into a certain Subdivision Agreement dated June 12, 2024, setting forth certain conditions with respect to the development of property owned by Owner to be known as Eagles Landing Subdivision; and

WHEREAS, the Parties desire to amend the Subdivision Agreement as provided herein.

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants contained herein, the Parties agree as follows:

- 1. Section 2 (j) of the Subdivision Agreement is here by deleted and the following placed in its stead:
 - j. That, upon approval of the Final Plat by the Village, the District shall pay the Village a payment in lieu of dedication of **parkland** in accordance with the Land Subdivision Ordinance of Eagle, Nebraska. One hundred percent (100%) of the forgoing payment shall be a general obligation of the District.
- 2. Section 2 (1) of the Subdivision Agreement is here by deleted and the following placed in its stead:
 - 1. The District shall, its own cost and expense, pay for all labor, material, and engineering costs in connection with the construction of the **internal** water system that will serve the Area to be Developed as shown on the construction plans approved by the Village. Construction of said internal water system shall be completed within two (2) years following approval of the Final Plat. One hundred percent (100%) of the entire cost of the installation of internal water system shall be specially assessed against the property within the Area to be Developed.
- 3. Except as otherwise provided herein, all other terms and conditions of the Subdivision Agreement shall be deemed incorporated herein and shall be made part of this First Amendment, and shall continue in full force and effect.

Motion by Caylor, second by Hochstein, to approve the execution of the Interlocal Agreement between the Village of Eagle and SID No. 12, Cass County, Nebraska. Voting: Ayes – Dobbins, Hochstein, Caylor, Todd. Nays – Meier. Motion carried.

Discuss/possible action: Drainage concerns at 500 South 2nd Street – The Village Board generally agreed to have more dirt removed to widen and deepen the ditch on the north side of D Street between 2nd and 3rd Streets and evaluate the effectiveness. No further action taken.

Discussion: Allowing chickens within the corporate limits – The Village Board discussed the pros and cons of the proposal and decided to set up a committee to research this

item in greater detail. Caylor and Hochstein will be the Village Board representatives and the Village will reach out to the community for volunteers to sit on the committee.

Report on Streets and Maintenance – The report on Streets and Maintenance was provided as a written report from the Maintenance Department. The 6th Street and 2nd Street paving project has been completed. The annual State of Nebraska Pool Inspection has been completed for 2024.

Report on Wells and Sewer – The report on Wells and Sewer indicated that 6 loads of sludge have been transported from the facility in the last month. The well drawdown tests have been performed for June.

Motion by Hochstein, second by Meier, to approve minutes as typed for the previous meeting. Voting: Ayes – 5. Motion carried.

Report from Committees and Boards – Caylor reported that the Health Board will be setting an upcoming meeting in the near future. Meier presented a pool/park report indicating some vandalism/graffiti issues at the park restrooms which are being resolved. Meier reported on a pool incident of foul language and non-adherence of pool rules by several children which has been addressed.
